RULES
AUBURN USBC WBA – SENIOR SINGLES TOURNAMENT
Please retain this portion

1. All entrants must be in good standing in the Auburn USBC WBA.
2. Age as of March 1, 2010 will determine which age group the bowler must participate. All entrants must be at least 55 years of age. Proof of age may be required.
3. The tournament consists of a handicapped 3- game singles event.
4. Entrants shall use their highest USBC average as a regular bowler or as a substitute bowler in the following order:
 - a. 2008-2009 winter season, 21 games or more.
 - b. 2009 summer season, 21 games or more.
 - c. As of January 1, 2010 of 21 games or more.
 - d. 12 games as of the day of the tournament.
 - e. All others will bowl scratch.
5. *Rules 319 A-2 and 319 – B, D, & E will be waived. Rule 319-A-3 will not apply. Handicap will be 100% of the difference between the entrant's average and 200.
6. Cash prizes will be awarded on a handicap basis, at least one in every ten entries. All prize fees collected in a division shall be returned 100% in that division.
7. In the event of a tie for first place in any division, prize money will be combined and divided equally.
8. The winner in each division will have their entry fee paid for the New York State USBC WBA Senior Singles (to be held in August 2010), if they plan to attend.
9. The Auburn USBC WBA representatives to the NYS USBC WBA Senior Singles Tournament will be determined by the highest pin fall with handicap in each classification. If the 1st place winner is unable to attend, alternate selections will be made in order of finish from the top three in each division. In case of a tie for first place, the highest single game of the series with handicap will determine the winner.
10. All protests should be filed with the tournament director and must comply with Rule 329. Any variation in the rules shall be decided by the tournament committee.
11. Entrants should arrive 30 minutes prior to the beginning of the squad.
